## RULES

- Absolutely NO parties or reunions that bring in extra outside traffic into the campground are permitted at any time.
- Only **ONE** camping unit per site (includes camper sites and tent sites). **ALL** back-in sites must have units backed into them (you cannot pull into the site if it's a back-in).
- EZ- Ups and screen rooms are allowed as a temporary shelter but not allowed as a permanent shelter. They must be anchored so they do not fly away in strong wind.
- All recreational vehicles must be registered and in good working order. Only factory manufactured units are allowed. Guest's cannot modify the Parks electric, water, or sewer connections. We highly recommend using a surge protector at the pedestal and water regulator to prevent damage.
- Please maintain a neat and orderly site. Items may be stored under your RV if they are in rubber totes and/or presented in a neat appearance. The following flags are allowed to be displayed at your site throughout the campground: international flags, American, Coast Guard, POW, MIA, veterans, sports or decorative flags such as holiday, seasonal, or garden.
- Pets must be kept on a leash and restrained when not inside an RV. Pets cannot be tied to trees or shrubs. Do not leave pets unattended outside an RV, even if restrained or inside of pet fence. You are expected to clean up after your pets. Excessive barking or noise from pets is not tolerated. **If complaints are received about your pets, you will be given a warning first but could be asked to leave the campground (all payments forfeited)** if complaints continue. Do not allow your pets on other sites for any reason.
- Keep your neighbors in mind. Quiet time is 11pm. Please keep an eye on your children. Do not ride a bicycle or drive a golf cart through another person's campsite. Be neighborly and respectful of others. **Complaints will result in being asked to leave the campground (all payments forfeited).**
- **Please remember not to leave any trash on your campsite or in the fire rings when checking out.** There is a dumpster available at every bathhouse for garbage disposal.
- No sewage or gray water from tents, campers, or recreational vehicles shall be disposed of on campground premises except at the sewage disposal station located at Bathhouse #2.
- Vehicles or equipment shall not be washed within the campground.
- **NO SMOKING/VAPING INSIDE BUILDINGS OR WITHIN 25 FEET OF ANY PLAYGROUNDS OR BUILDING ENTRANCES.**
- Park Management has the right to move campers to another site due to maintenance, business needs, etc.
- The park is not responsible for damages, injury, or loss to either person or property by fire, theft, weather, or Acts of God.
- Guests must obey all federal, state, and local laws regarding the ownership and possession of firearms. Firearms are not permitted in any property buildings or common areas. Guests may have a firearm in a locked, private vehicle in parking areas if permitted by law. The discharge of firearms, BB guns, air guns/ rifles, or similar devices are strictly prohibited. Fireworks are not allowed.

- All RV owners, guests, and visitors are expected to follow the instructions of KHRVR Management, Security, and local authorities. Failure to do so may result in departing from the park without a refund.
- Pictures posted on our Facebook pages or taken by our staff may be used in social media posts. If you do not wish to have your pictures used, please contact the Business Office.

## **GATE POLICY & INFORMATION**

- Each campsite will be assigned **two** cards along with their vehicle passes for that site that will give you access to the Campground. This will be the only way accessible into the campground once the store is closed.
- **These cards must be returned at the end of your stay when you checkout or there will be a \$25.00 charge per card applied to your reservation profile for not returning them.**
- Each campsite will be allowed 2 guest passes. After quiet time begins (11pm) all guests will be asked to remove their vehicle but are allowed to park at the entrance of the campground but quiet time is still in effect so please respect your neighbors.
- Those who want to ride through via vehicle or just walk through the campground to check out spots, amenities, etc. can receive a visitor pass at the campground store during stores operating hours.

## **GOLF CARTS / ATVS / SCOOTERS / BIKES, ETC**

- **Any sit-down transportation (ex – hoverboards with seat attachments) needs a 6ft pole with flag attached.**
- Campers are welcome to bring their own golf carts. **Drivers must have a valid driver's license.** Mules, gators, razors, ATVs, gas or electric dirt bikes, gas powered bikes, or other utility vehicles are prohibited. No golf carts on trails. **No bicycles, hoverboards, or scooters to be rode after dark. NO Exceptions!**
- Failure to comply to any of the rules will result in asking these vehicles to be parked for the remainder of your stay.

## **MAKING RESERVATIONS**

All campsites can be reserved up to a year in advance. You can make reservations online at [levijacksonpark.com](http://levijacksonpark.com) or give the campground a call at (606) 330-2130 ext. #1. A \$3.50 fee is charged per reservation. You must pay for the entire reservation at the time of booking.

April 1<sup>st</sup> – November 2<sup>nd</sup>: During this time frame there will be a 14-day maximum stay for all sites. Longer stays may be available but customer must give a written reason for the extended stay and submit to the Tourism Commission to be approved.

November 3<sup>rd</sup> – March 31<sup>st</sup>: All sites will transition to 50% off and campers can stay for 30 days. After the 30 days, additional time will need to be approved. In order to get this discount, you would need to make this reservation once the half off goes live in November, **you cannot back up and apply this discount if you make the reservation before the promo code is live.** Limited sites and amenities will be available during this time.

## **CANCELLATIONS / RES. CHANGES / NO SHOWS**

Call the park at (606) 330-2130 Extension #2 to cancel or make changes to your reservation. Changes and cancellations must be made at least **3 days** prior to your check in date. Changes made to site type that results in a overage will be applied to your camping profile instead of issuing refund (this can be applied to your next stay)

**Cancellation Policy:** \$3.50 is always nonrefundable, \$10.00 cancellation fee deducted. Remaining amount refunded - if reservation was made through us at the park and was paid with a card, we can refund that card if it's within a few weeks' timeframe. If you made it through the park and paid with cash or check, a refund check will have to be mailed back to you.

**No Show Policy:** If you suspect you will arrive late, please call to inform staff. If no contact has been made it will be parked as a "no show" 24 hours after your check in date. **Once a reservation is marked NO SHOW it can no longer be transferred, changed, or refunded.**

**Checking Out Early:** Once a reservation is checked in, we **cannot** offer refunds or transfer your unused dates to a different time frame.
